Such shares of Class B Common Stock represent 3.206% of the outstanding Class B Common Stock. Assuming the conversion of all outstanding shares of Class B Common Stock into Class A Common Stock, the 36,476,326 shares of Class A Common Stock reported as being beneficially owned by the reporting persons in this Schedule 13G would represent 14.890% of the outstanding Class A Common Stock.

Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.
