**REGISTRATION OF ADDITIONAL SECURITIES  
PURSUANT TO GENERAL INSTRUCTION E**

**2016 Equity Incentive Plan**

The 2016 Equity Incentive Plan (the "2016 Plan") of Nutanix, Inc. (the "Registrant") provides that the total number of shares of the Registrant's Class A common stock, \$0.000025 par value ("Class A common stock"), reserved for issuance under the 2016 Plan will be automatically increased on the first day of each fiscal year beginning in the Registrant's fiscal year ended July 31, 2018, by an amount equal to the least of (i) 18,000,000 shares, (ii) five percent (5%) of the outstanding shares of all classes of the Registrant's common stock as of the last day of the Registrant's immediately preceding fiscal year, or (iii) such other amount as the Administrator (as defined the 2016 Plan) may determine. Accordingly, on August 1, 2023, the number of shares of Class A common stock reserved under the 2016 Plan increased by an additional 11,980,343 shares (or 5% of the outstanding shares of common stock as of July 31, 2023) (the "Additional Shares").

The Additional Shares are securities of the same class as other securities for which the Registration Statement on Form S-8 (File No. 333-213888) (the "Initial Form S-8") was filed with the U.S. Securities and Exchange Commission (the "Commission") on September 30, 2016. Pursuant to General Instruction E to Form S-8, this Registration Statement hereby incorporates by reference the contents of each of the Initial Form S-8, the Registrant's Registration Statement on Form S-8 filed with the Commission on September 18, 2017 (File No. 333-220517), the Registrant's Registration Statement on Form S-8 filed with the Commission on September 24, 2018 (File No. 333-227490), the Registrant's Registration Statement on Form S-8 filed with the Commission on August 28, 2019 (File No. 333-233499), the Registrant's Registration Statement on Form S-8 filed with the Commission on September 23, 2020 (File No. 333-248992), the Registrant's Registration Statement on Form S-8 filed with the Commission on September 21, 2021 (File No. 333-259700), and the Registrant's Registration Statement on Form S-8 filed with the Commission on September 21, 2022 (File No. 333-267539), except that the provisions contained in Part II of such earlier registration statements are modified as set forth in this Registration Statement.

Any such statement so modified or superseded shall not be deemed, except as so modified or superseded, to constitute a part of this Registration Statement.
