The Company has two classes of common stock outstanding, Class A Common Stock and Class B Common Stock. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except

with respect to voting and conversion. Each share of Class B Common Stock has ten votes and each share of Class A Common Stock has one vote. Assuming full conversion of all the currently outstanding Class B Common Stock, the 41,400 shares of Class A Common Stock and 2,945,670 shares of Class B Common Stock would represent 3.33% of the total Common Stock outstanding.
